

8. Quoted Price :-

- (a) Remuneration of staff, quoted below minimum wages applicable for staff, in the Deputy. Commissioner, Dehradun (UKD). shall render the bid disqualified for evaluation.
- (b) The Bidder shall quote unit rate which shall comprise of Daily remuneration, EPF, ESI, GST & Other statutory costs and service charges (including profit and administrative charge) in the format of quotation only attached (Annexure-A/BOQ).
- (c) The service tax and any other such tax liable to paid by client shall be quoted by the bidder separately.
- (d) The rate quoted shall be fixed for the duration of the contract and shall not be subject to adjustment except the statutory provisions, if amended.
