
- iv) Tender forms are issued free of cost to the firms who are registered with the Ministry of Transport, New Delhi.
- v) All firms who are not registered with Ministry of Surface Transport are required to deposit Earnest Money as mentioned above along with tender form.
- vi) All Firms are to be deposited original copy of EMD at reception of SPT Bn, (ADM Block), ITB Police, Karera, before bid submission closing date & Time. Following Certificate is also required for submission of E-bid.

The Firm has to attach Registration Certificate of Minimum 04 Trucks, Service Tax Code registration (from ST-2) and attested copy of PAN.

- vii) The firms or their reps. desirous of being present during the time of the OPENING OF TENDER should come and get their "Gate pass" one day before from the Reception, to avoid any hassle in getting entry into the SPT BN.
