1. The Commandant 39th BN , ITB Police Force, on behalf of the President of India invites online Item rate tender from Specialized Agencies in www.eprocure.gov.in & www.itbp.gov.in CPPPortal for the following work.

4. The bid document consisting of plans, specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from website www.eprocure.gov.in & www.itbp.gov.in
5. The tender can only be submitted after uploading the mandatory scanned documents as per list given below.
 - I. Copy of GST registration, Pan Card.
 - II. Tender form duly signed.
 - III. Scanned copy of EMD.
 - IV. Work experience certificate.
 - (a) Three similar completed works each of value not less than Rs. 86,480/-
OR
 - (b) Two similar completed works each of value not less than Rs. 1,29,720/-
OR
 - (c) One similar completed work each of value not less than Rs. 1,72,960/-

Similar work shall mean works of "The value of executed works shall be brought to current costing level by enhancing the value of work at simple rate 7% per annum; calculated from the date of completion to last due of receipt of application for bids.

6. The bidder will ensure physical submission of EMD in favour of **Commandant 39th BN , ITB Police, Greater Noida** the form of Demand draft, Banker's Cheque/ Deposit at call receipt/ Fixed Depositi Receipt at **Commandant 39th BN , ITB Police, Greater Noida** .
7. The intending tenderer has to fill all the details such as Banker's name, Demand Draft/Fixed Deposit Receipt /Pay Order/ Banker's Cheque/Bank Guarantee number, amount and date. The amount of EMD can be paid by multiple Demand Draft / Pay Order / Banker's Cheque / Deposit at call receipt / Fixed Deposit Receipts -A part of earnest money is acceptable in the form of bank guarantee also. In such case, 50% of earnest money or Rs. 20 lac, whichever is less, will have to be deposited in shape prescribed above, and balance in shape of Bank Guarantee of any scheduled bank.
8. Those contractors not registered on the website mentioned above, are required to get registered beforehand. If needed, they can be imparted training on online bidding process as per details available on the website.
9. Bidder should not have past track record of delaying works.
10. On opening date, the contractor can login and see the bid opening process. After opening of bids he will receive the competitor bid sheets.
11. Contractor can upload documents in the form of JPG format and PDF format.
12. Contractor must ensure to quote rate of each item, if any cell is left blank and no rate is quoted by the tendered, rate of such item shall be treated as "0" (ZERO). However, if tendered quotes Nil rates against each item in item rate tender or does not quote any percentage above/below on the lowest amount of the tender or any section/sub head in percentage rate tenders, the tender shall be treated as invalid and will not be considered as lowest tender.
13. The required documents meeting the criteria to qualify as "approved and eligible" contractors documents as mentioned under Para "List of Documents to be scanned and uploaded by the agency and hard copies received subsequently" shall be checked first, while opening the bid. The financial bid of only those agencies shall be opened who are found to be eligible agencies, as per this NIT.
14. The department reserves the right to reject any prospective application without assigning any reason and to restrict the list of qualified contractors to any number deemed suitable by it, if too many bids are received satisfying the laid down criterion.
