Scanned copy of Earnest Money shall be uploaded online before due date and physically submitted by the critical date of submission as prescribed in notice in Envelope Cover- 01.

4. Tender documents, Scanned copy of Contractor Registration Certificate, Experience Certificate of previous work done of at least 02 works successfully completed in same nature of work, Pan Card, and Income Tax Return for the last two years, Valid Goods & Service Tax Identification Number (GSTIN) or Copy of Applied for, Earnest Money & Tender Cost Fee will have to upload online after self certification of all requisites documents before critical date of submission.

5. **Eligibility Criteria:**


Contractors who fulfill the following requirements shall be considered as eligible bidder:

Contractors should have successfully completed the works as mentioned below during the last 05 (five) years ending last day of the March-2019:

- i) 03 (three) similar works each costing not less than **40%** of estimated cost ,or
- ii) 02 (two) similar works each costing not less than **60%** of estimated cost, or
- iii) 01 (one) similar works each costing not less than **80%** of estimated cost executed under Central/ State Government Department/ Central/ State Autonomous Body / Central/Central/ State Public Sector Undertaking. **Completion Certificate** issued by Competent Authority will only be considered as credential .

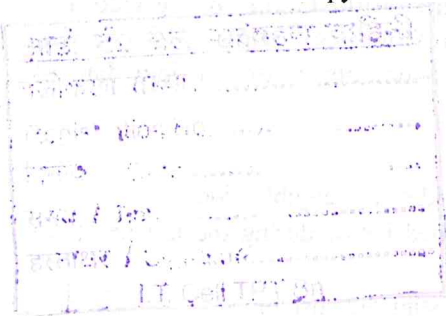
