PWD, Railways, Telecom Department, MES and State Irrigation/Public health department for the following work.

Tender Cost:- Rs 500/- (Non Refundable) for each tender in the form of Demand Draft/ Banker's Cheque from any Nationalized/ Scheduled bank in favor of "Commandant, TPT Bn., ITBP, payable at Chandigarh." Scanned copy of tender fee shall be uploaded online before due date and physically submitted by the critical date of submission as prescribed in notice in Envelope Cover- 01.

3. Earnest Money Deposit as mention above for each tender in the form of Demand Draft/ Banker's Cheque/Fixed Deposit Receipt/ Deposit Call Receipt (validity of EMD upto 90 days) from any Nationalized/ Scheduled bank in favor of "Commandant, TPT Bn., ITBP, payable at Chandigarh. Scanned copy of Earnest Money shall be uploaded online before due date and physically submitted by the critical date of submission as prescribed in notice in Envelope Cover- 01. Tender without EMD will be summarily rejected.

4. Bidder's should upload the duly signed Tender documents, Scanned copy of Contractor Registration Certificate, Registered Contractors in appropriate class with CPWD, U.T. PWD, Railways, Telecom Department, MES, State Irrigation/PHED and State PWD(B&R) Experience Certificate of previous work done of last **05 (five) years** as mentioned in **Para-5**, PAN Card, Income Tax Return for the last three years, Valid Goods & Service Tax Identification Number (GSTIN), valid P.F. & E.S.I. Registration, Earnest Money & Tender Cost Fee online in CPP Portal after self certification of all requisites documents before critical date of submission.

5. Eligibility Criteria:

Contractors who fulfill the following requirements shall be considered as eligible bidder:

Contractors should have successfully completed the works as mentioned below during the last 05 (five) years ending last day of the March-2019:

- 03 (three) similar works each costing not less than **40%** of estimated cost, or
- 02 (two) similar works each costing not less than **60%** of estimated cost, or
- 01 (one) similar works each costing not less than **80%** of estimated cost executed under Central/ State Government Department/ Central/ State Autonomous Body / Central/Central/ State Public Sector Undertaking. **Completion Certificate** issued by Competent Authority will only be considered as credential .
- Similar work shall mean: Renovation of Building (Office/Residential Building) works/ special repair of building works.**

The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum calculated from date of completion to last date of applications for tenders.

6. The Bid document consisting of specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract and other documents/drawings if any can be seen and downloaded from website.

7. Rate quoted by bidders in financial bid(BOQ) should be inclusive of all taxes like GST etc.



11. Bid validity period is 90 days from the submission date of bid .Bid will be opened at Engg. Branch,TPT BN,Chandigarh office on scheduled date.
