2 इस संदर्भ में अवगत कराना है कि (1) जो कार्मिक Field /High altitude/CI Ops areas में तैनात हैं, उन्हें वर्ष के दौरान तैनाती स्थान से गृहनगर एवं वापिसी के लिये दिनांक 01.07.17 से अतिरिक्त फ्री रेल्वे वॉरन्ट/अतिरिक्त एफ.एल.पी.सी देय करने हेतु स्वीकृत प्रदान की गई है, (2) कॅम्पनसेशन फॉर हाउसिंग स्कीम के तहत अराजपत्रित कार्मिकों को दिनांक 01.07.17 से फील्ड एरिया या नॉन फील्ड एरिया में तैनाती के दौरान नियमानुसार अलग-अलग दरों पर मकान किराया भत्ता स्वीकृत करने का प्रावधान रखा गया है ।

3 बल के सभी योग्य कार्मिकों को उपरोक्त दोनो बिन्दुओं/विषयों का लाभ तभी देय किया जा सकता है, जब बल की सभी फंटियर/क्षे.मु./वाहिनियों/अन्य इकाईयों को अतिरिक्त फ्री रेल्वे वॉरन्ट./ अतिरिक्त एफ.एल.पी.सी. स्वीकृति हेतु Field/High altitude/CI(Ops) areas एवं मकान किराया भत्ता स्वीकृत हेतु फील्ड एरिया या नॉन फील्ड एरिया में वर्गीकृत किया जाएगा, अन्यथा कार्मिकों को इसका लाभ तब तक देय नहीं होगा, जब तक बल की सभी इकाईयों को वर्गीकृत नहीं किया जाता है । इस संदर्भ में इस कार्यालय के अंतर कार्यालय टिप्पणी संख्या 137 दिनांक 20.02.18 का भी अवलोकन करें, जिसके तहत पूर्व में भी इसी विषयक अनुरोध किया गया था ।

4 चूंकि उपरोक्त दोनो बिन्दुओं/विषयों पर ऑप्स शाखा महानिदेशालय स्तर पर आवश्यक कार्रवाई किया जाना अपेक्षित है । अतः अनुरोध है कि बल की जो वाहिनियों/क्षे.मु./फंटियर /इकाईयों Field/Non-field/High altitude/CI(Ops) areas में स्थापित हैं, उनका महानिदेशालय स्तर पर वर्गीकृत करने के उपरान्त सभी इकाईयों को अतिशीघ्र परिचालित करने की कृपा करें, ताकि योग्य कार्मिक को उपरोक्त दोनो विषयों पर लाभ प्राप्त हो सकें ।

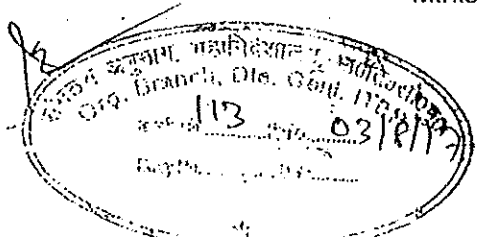
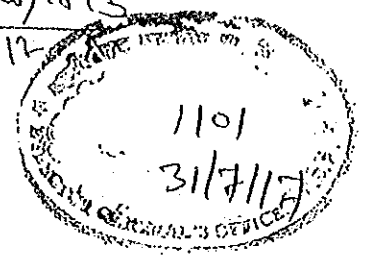

OFFICE MEMORANDUM

Sub: Implementation of recommendations of the Seventh Central Pay Commission regarding provision of compensation for housing to PBORs of CAPFs, Assam Rifles and NSG.

Consequent upon the acceptance of the recommendations of the 7th Central Pay Commission by the Government vide Ministry of Finance's Resolution No.11-1/2016-IC dated 6th July, 2017, the President is pleased to sanction provision of compensation for housing to Personnel Below Officer Rank (PBORs) of Central Armed Police Forces (CAPFs), Assam Rifles and NSG, who are not provided with rent free accommodation or sanctioned HRA in accordance with Ministry of Finance OM No.2/5/2017-E.II(B) dated 7th July, 2017, as under:-

An employee with dependents, during field posting or staying in Barracks as functional requirement will be eligible for accommodation for his dependents anywhere in the country.

* Provided government accommodation is not available for the dependents at Selected Place of Residence. If government accommodation is available, no HRA is payable.

** Reduced HRA means rate of HRA applicable reduced by 5 percent. However, the reduced amount cannot be less than the lowest rate of HRA applicable to Class Z cities/towns. Allowance is available provided employee is required to stay in barracks as a functional requirement and government accommodation is not available for the dependents at Selected Place of Residence. If employee is staying in barracks by choice or government accommodation is available at Selected Place of Residence, no HRA is payable.

@ Reduced HRA means rate of HRA applicable reduced by 5%. However, the reduced amount cannot be less than the lowest rate of HRA applicable to Class Z cities/towns. Allowance is available provided employee is required to stay in Barracks as a functional requirement. If employee is staying in Barracks by choice, no HRA is payable.

Provided government accommodation is not available, else no HRA is payable.

2. The rates of HRA will not be less than Rs.5400/-, Rs.3600/- & Rs.1800/- at X, Y & Z class cities respectively.
3. The rates of HRA will be revised to 27%, 18% and 9% for X,Y & Z class cities respectively when Dearness Allowance (DA) crosses 25% and further revised to 30%, 20% and 10% when DA crosses 50%.
4. This supersedes all the existing orders for grant of Compensation in Lieu of Quarters (CILQ) and Family Accommodation Allowance (FAA) to CAPF personnel.
5. These orders shall be effective from 1st July, 2017.
6. This issues as per MoF (DoE) Resolution No.11-1/2016-IC dated 6th July, 2017, as vetted by the Integrated Finance Division of this Ministry vide their Dy. No.3396486/Fin.II/17 dated 31.07.2017.


