**Sub: Grant of Additional Free Railway Warrant/Additional LTC to CAPFs, AR & NSG**

The undersigned is directed to refer to DG, CRPF UO No.P.1.1/2017-PCC dated 21.12.2017, seeking clarification whether CAPFs personnel are entitled to Additional LTC once in a calendar year in the event of death, serious illness or marriage of a member of the family subject to reimbursement of only 50% of the rail fare, as was admissible prior to implementation of 7<sup>th</sup> CPC recommendations.

2. The matter has been examined in consultation with IFD of this Ministry, and it is clarified that CAPF personnel were earlier granted 50% of rail fare in a year for to and fro journey to hometown in specified circumstances, like death, illness, marriage etc. The new guidelines issued vide MHA's OM dated 31.07.2017, extend full free railway warrant to all CAPF personnel in a year without imposing conditions of death, illness, marriage etc. New guidelines are in supersession of earlier guidelines and are in force for the time being.

3. CRPF is, therefore, requested to take action accordingly.
