OFFICE MEMORANDUM (CORRIGENDUM)

Sub: **Implementation of recommendations of the Seventh Central Pay Commission regarding provision of compensation for housing to PBORs of CAPFs, Assam Rifles and NSG.**

This Ministry, vide OM of even number dated 31.07.2017, had conveyed sanction for provision of compensation for housing to Personnel Below Officer Rank (PBOR) of CAPFs, AR and NSG, who are not provided with rent free accommodation or sanctioned HRA, which inter alia, mentioned that for 'Field Posting', if PBOR has no dependents, full HRA would be applicable at Class Z city, i.e. 10 per cent of Basic Pay.

2. A reference has been received in this Ministry, seeking clarification whether the full HRA applicable at Class 'Z' city is 10 percent or 8 percent of Basic Pay, as the rate of HRA applicable for 'Z' class cities is 8 percent, as per Ministry of Finance OM No.2/5/2017-E.II(B) dated 07.07.2017.

3. The matter has been examined in consultation with Ministry of Finance and it is clarified that PBORs, who are not provided with rent free accommodation or sanctioned HRA, in 'field posting' and has no dependents, will be entitled to 'full HRA applicable at Class 'Z' city, i.e. 8 per cent of Basic Pay'. This Ministry's OM of even number dated 31.7.2017 stands modified accordingly.

4. This issues with the concurrence of Ministry of Finance (Department of Expenditure) vide their ID No.A-27023/7/2017/E.II B/7th-CPC dated 19.2.2018 and Integrated Finance Division of this Ministry vide Dy. No.3396486/Fin.II/18 dated 5.4.2018.
