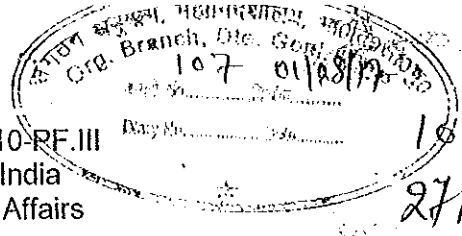

In partial modification to this Ministry's OM of even number dated 17.10.2013 and 7.8.2014, vide which a mechanism has been framed to regulate entitlement of allowances while on temporary transfer beyond 180 days, the undersigned is directed to convey approval of the competent authority to waive the condition of applicability of the said OMs dated 17.10.2013 and 7.8.2014 from prospective date.

OFFICE MEMORANDUM

Subject: Regarding Court Order dated 18.3.2013 pronounced in WP(C) 1731/2013 filed by Insp(M) Harvinder Singh, WP(C) 1733/2013 filed by SI(M) Suresh Kumar and WP(C) No. 1734/2013 filed by SI/M Nekched Prasad before Hon'ble Delhi High Court for sanction of HRA/Transport Allowance for attachment period - entitlement of allowances while on attachment/ temporary transfer beyond 180 days.

The Hon'ble High Court of Delhi while considering grant of HRA, Transport allowance and all other admissible benefits while on attachment duties vide order dated 18.3.2013 in WP(C) 1731/2013 filed by Insp(M) Harvinder Singh, WP(C) 1733/2013 filed by SI(M) Suresh Kumar and WP(C) No. 1734/2013 filed by SI/M Nekched Prasad (all belongs to CRPF), has also directed the respondents to ensure and create a mechanism which would verify such claims made and pass appropriate orders in a time bound manner preferably within eight weeks after receiving representations to avoid future litigations.

2. Accordingly, following mechanism has been framed to dispose of such claims during attachment/temporary transfer of officers/men with offices/establishments other than their declared headquarters, at the rates as admissible at the place where they are on temporary transfer/attachment to avoid future litigations:-

- (i) Personnel on temporary transfer within 180 days will be entitled for DA as per provisions of SR-73.
- (ii) On further extension of temporary transfer period beyond 90 days, the place of temporary transfer may be declared as temporary headquarters under provisions of SR-59.
- (iii) On declaration of temporary headquarter personnel on temporary transfer will be eligible for HRA, Transport Allowance, etc.
- (iv) Such declaration of temporary headquarter will be done by Directorate General of concerned Head of Department as per existing instructions contained in FR/SRs.

3. The above provision will be effective prospectively from the date of issue of this order.

4. This issues with the concurrence of Ministry of Finance, Deptt. of Expenditure vide their J.D. No. 2(20)/2011-FI(B) dated 11.10.2013 and Integrated Finance Division of this Ministry vide their Dy. No. CF-321031/Fin.II/2013 dated 17.10.2013.

OFFICE MEMORANDUM

Subject: Entitlement of allowances while on temporary transfer beyond 180 days.

In partial modification to this Ministry's OM of even number dated 17.10.2013, vide which a mechanism has been framed, in pursuance to the Court Order dated 18.3.2013 pronounced in WP(C) 1731/2013 filed by Insp(I) Harvinder Singh, WP(C) 1733/2013 filed by SI(M) Suresh Kumar and WP(C) No.1734/2013 filed by SI/M Nekched Prasad before Hon'ble Delhi High Court, the undersigned is directed to modify the mechanism, to dispose of claims of HRA/Transport allowance on temporary transfer of officers/men with offices/establishments other than their declared headquarters, at the rates as admissible at the place where they are on temporary transfer, as under:-

- (i) Personnel on temporary transfer within 180 days will be entitled for DA as per provisions of SR-73.
- (ii) On extension of temporary transfer period beyond 90 days, the place of temporary transfer may be declared as temporary headquarters under provisions of SR-59.
- (iii) Grant of HRA/Transport Allowance to the employees initially on Temporary Transfer followed by declaration of the place of 'Temporary Transfer' as 'Temporary Headquarters', shall be governed by the provisions of Para 4(b)(xi) of Ministry of Finance/Department of Expenditure OM No.2(37)/E.II(B)/64 dated 27.11.1965, as amended from time to time.
- (iv) Such declaration of temporary headquarter will be done by Directorate General or concerned Head of Department as per existing instructions contained in FR/SRs.

2. This is effective from 17.10.2013 i.e. the date of issue of this Ministry's OM dated 17.10.2013.

3. This issues with the concurrence of Ministry of Finance, Deptt. of Expenditure vide their I.D. No.2(20)/2011-E.II(B) dated 4.8.2014 and Integrated Finance Division of this Ministry vide their Dy. No. CF-3244325/Fin.II/2014 dated 7.8.2014.
