

**Additional specifications and other Terms & Conditions/Eligibility Criteria for eBid on GeM for procurement of 245 Desktop Computers**

- 1) TPM Module: - TPM Module should be provided for protection of critical data.
- 2) USB Type C: - 01 No.
- 3) Audio: - HD Audio Realtek ALC662.
- 4) BIS Certificate: - Yes.
- 5) EPEAT Gold Certificate: - Yes.
- 6) Make of Desktop Computer: - Name of the OEM of Desktop Computer offered by a bidder should be clearly mentioned in his/her eBid.
- 7) Model Name/Number of Desktop Computer: - Exact model name/number of Desktop Computer offered by a bidder should also be mentioned clearly in his/her eBid.
- 8) Datasheet of Desktop Computer: - Datasheet of offered Desktop Computer/Monitor containing all technical specifications should be available on official website of OEM.
- 9) Web-page address of datasheet of Desktop Computer: - Bidders shall compulsorily provide correct web-page address of datasheet from official web-site of OEM of their offered Desktop Computer/Monitor.
- 10) MAF-Authorization is Mandatory: - MAF-Authorization from OEM is mandatory for all the bidders who are not OEM.
- 11) Obtaining MAF-Authorization: - MAF-Authorization should be obtained specifically **in reference to our eBid Number** from OEM on their letterhead issued under the seal & signature of Authorized Person.
- 12) Submission of scanned copies of MAF-Authorization, BIS Certificate, TCO 6.0 Certificate for Monitor, ROHS Certificate and EPEAT Gold Certificate: - Scanned copies of MAF Authorization, BIS Certificate, TCO 6.0 Certificate for Monitor, ROHS Certificate and EPEAT Gold Certificate should be emailed on our email ID itproc@itbp.gov.in before closing of eBid. Scanned copies of MAF Authorization, BIS Certificate, TCO 6.0 Certificate for Monitor, ROHS Certificate and EPEAT Gold Certificate received in our given email account after closing of respective eBid **shall not be considered**.
- 13) Submission of Original Copy of MAF-Authorization: - Bidders would have to submit original copy of same MAF-Authorization on demand within 2 days.
- 14) In case of Non-Submission of MAF-Authorization, Non-Submission of BIS Certificate, Non-Submission of TCO 6.0 Certificate for Monitor, Non-Submission of ROHS Certificate, Non-Submission of EPEAT Gold Certificate and Non-Compliance of Technical Specifications: - Bid of such bidder shall be treated as Non-Responsive and would be rejected summarily and no query or correspondence whatsoever in this regard shall be entertained.
- 15) Offer of Higher/Better Specifications: - Specifications given are minimum however, bidders are free to offer higher/better specifications.
- 16) In case bidders find it unfeasible in GeM portal to fill-in the offered specifications during eBids, they may provide specifications of their offered product (*including make, model, webpage address of datasheet*) on their letterhead duly sealed and signed by the authorized person and it should be emailed on our email ID itproc@itbp.gov.in before closing of eBid. Scanned copies of such document received in our given email account after closing of eBid **shall not be considered**. Further, bidders would have to submit original copy of the same document on demand within 02 days.
