## Citizen's Charter of ITB Police Force

#### Preface:-

Indo-Tibetan Border Police Force was raised in the wake of the Chinese aggression in 1962 with a modest strength of 4 Bns under the principle of 'One Border One Force'. Initially conceptualized as an integrated "Guerrilla-cum-intelligence-cum-fighting force" self-contained in supplies, communication and intelligence collection. With a passage of time, it evolved into a conventional Border Guarding Force with the motto 'Shaurya-Dridhata-Karamnishtha' to vindicate the confidence reposed in them by fellow countrymen.

Today ITBP is guarding 3488 Kms of Indo-China Border and is manning 157 Border Outposts at an altitude ranging from 9000' to 18700' in the Western, Middle and Eastern Sector of the Indo – China Border along the Himalayas from Karakoram Pass in Ladakh to Jachep-La in Arunachal Pradesh. ITBP Units are also deployed in Naxal-affected areas of Chhattisgarh, Jharkhand, Bihar & Orissa states. ITBP Headquarters is located at Block 02, CGO Complex, Lodhi Road, New Delhi-110003. The ITBPF is headed by Director General.

ITBP is organized into Five Frontier Headquarter headed by Inspectors General.

#### Frontier Headquarters:-

- North West Frontier, Chandigarh.
- > Northern Frontier-Dehradun
- North-East Frontier, Itanagar.
- > Eastern Frontier, Lucknow
- > Central Frontier-Bhopal.

There are 15 Sector Headquarters, 16 Training Centres, 56 Service Bns, 4 Specialist Bns (Logistics Establishments) Service and Supply Bns, 04 Logistics Establishment, 2 Disaster Management Bns placed under National Disaster Response Force (NDRF).

- > Safeguarding of borders of India and promote sense of security among the people living in border areas;
- ➤ Prevent trans-border crimes, smuggling, unauthorized entry into or exit from the territory of India and other illegal activity;
- ➤ Provide security to sensitive installations, VVIPs/VIPs and PPs of security risk;
- > Restore and preserve order in any area in the event of disturbance therein.

# 5. Additional Responsibilities assigned to ITBP:-

- > Deployment of ITBP Coys during General Elections.
- ➤ Deployment of ITBP commandos and troops for ensuring security during special occasions of national importance like Independence Day and Republic Day celebrations in Delhi.
- Deployment in Afghanistan and UN Peacekeeping Mission in Congo.
- ➤ Providing Internal Security to various installations of national importance throughout the country as directed.
- ➤ Playing pivotal role in conducting Mansarovar Yatra and providing help and succour to the pilgrims undertaking the yatra. Women personnel are inducted for security and help of Mahila Yatris.
- Apart from above activities, ITBPF ensures security in conducting Border Trade smoothly between India and China through Nathu-la at Sherathang on Indian side & Thungsingang in Chinese side. Lipulekh Pass in Uttarakhand which commenced w.e.f 1992 with trade mart at Gunji in Indian side and Takalakot in Chinese side.
- Rescue & Relief Operations:- ITBP conducts immediate rescue and relief operations whenever any natural disasters struck the Country.
- The Civic Action Programme (CAP) is the part of the comprehensive approach to the Border Management and in Naxal affected areas with focus on socio-economic development of the border areas as well as in the Naxal affected areas wherever required and to promote a sense of security amongst the people living there. In order to gain confidence of locals and for the management of perception, ITBP conducts Civic Action Programmes at regular intervals. Under this programme, various welfare / developmental activities like holding of medical camps, veterinary camps, excursion tours, sanitation drives, conducting of sports tournaments, distribution of

- radios/transistors, minor repairs of school buildings, road bridges, organizing computer training etc are undertaken by us.
- Information on Security and Cyber Security: ITBP has Crisis Management Plan for countering Cyber-attacks and Cyber Terrorism. ITBP is also having its internal Cyber Security Policy where precautionary steps are being followed while using various accesses via open network i.e. internet etc. Security auditing mechanism is functioning in ITBP.

#### 6. Grievance Redressal System:-

ITBP has a Citizen centric approach for Grievance Redressal. All Formations of ITBP including Directorate General are having grievance redressal system in place. Anyone who feels aggrieved may approach to Head of his/her nearest Formation of ITBP and explain about his/her grievance. The concerned Officer are taking every possible steps to redress grievances.
