

NOTICE INVITING e-TENDER

The Commandant (Engr), SHQ(TZP), ITBP on behalf of the President of India invites online **Percentage Rate bid** from approved and eligible firms/ contractors of CPWD, MES, Railway, BRO, State PWD and Telecom BSNL having valid registered under Building construction/ Composite category in appropriate class for the following work :-

- The enlistment of the contractors should be valid on the last date of submission of tenders. In case, the last date of submission of tender is extended, the enlistment of contractor should be valid on the original date of submission of tenders.
- The intending bidder must read the terms and conditions of **Tender form** carefully. He should only submit his bid if he considers himself eligible and he is in possession of all the documents required.
- Information and Instructions for bidders posted on website shall form of bid document.
- The bid document consisting of plans, specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from website www.eprocure.gov.in & www.itbp.gov.in.
- The tender can only be submitted after uploading the mandatory scanned documents as per list given below.
 - Scanned copy of Earnest Money with information regarding place of deposited.
 - Enlistment Order of the contractor in building category.
 - (A) GST Registration Certificate of the state in which the work is to be taken up, already obtained by the bidder.

(B) Under taking : If the bidder has not obtained GST registration in **Arunachal Pradesh** i.e. the state in which the work is to be taken up, then in such case the bidder shall upload following under taking with the bid document:
"If the work is awarded to me, I/We shall obtain GST registration certificate of the state , in which work is to be taken up, within one month from the date of received of award letter or before release of any payment by ITBP, whichever is earlier, failing which , I/We shall be responsible for any delay in payments which will be due towards me /us on a/c of the work executed and /or for any action taken by ITBP or GST department in this regard."



VI. List of Completed works and their completion certificates in support of work experience as per tender document.

Note : Bidder should ensure himself that above documents are uploaded in correct format and at correct location on the website.

- 6 Earnest Money of **Rs 5,75,500.00** in form of Banker's Cheque or Demand Draft or Fixed Deposit or Bank Guarantee receipt of any scheduled bank drawn in favour of DIG, SHQ (TZP), ITBP, Rangamati, Assam and deposit original EMD either in the office of Commandant (Engr) SHQ (TZP) or any nearest formation of ITBP within period of Bid submission time. Receipt of EMD obtained from the concerned Engineering Branch of any formation of ITBP, to be scanned and uploaded to thee-tendering website at the time of bid submission. (Format of receipt placed at page no 52 of Tender Form)
7. Those contractors not registered on the website mentioned above, are required to get registered beforehand. If needed, they can be imparted training on online bidding process as per details available on the website.
8. The intending bidder must have valid class-III digital signature to submit the bid.
9. Bidder should not have past track of delaying works
10. On opening date, the contractor can login and see the bid opening process. After opening of bids, he will receive the competitor bid sheets.
11. Contractor can upload documents in the form of JPG format and PDF format.
12. Contractor must ensure to quote rate of each item. The column meant for quoting rate in figures appears in pink colour and the moment rate is entered, it turns sky blue. In addition to this, while selecting any of the cells a warning appears that if any cell is left blank the same shall be treated as "0". Therefore, if any cell is left blank and no rate is quoted by the tenderer, rate of such item shall be treated as "0" (ZERO). However, if tenderer quotes Nil rates against each item in item rate tender or does not quote any percentage above/below on the lowest amount of the tender or any section/sub head in percentage rate tenders, the tender shall be treated as invalid and will not be considered as lowest tender.
13. The required documents meeting the criteria to qualify as "approved and eligible" contractors of CPWD, MES, Railway, BRO, State PWD Deptt. & Telecom BSNL etc along with other documents as mentioned under Para "List of Documents to be scanned and uploaded by the agency. The financial bid of only those agencies shall be opened who are found to be eligible agencies, as per this NIT.
14. The department reserves the right to reject any prospective application without assigning any reason and to restrict the list of qualified contractors to any number deemed suitable by it, if too many bids are received satisfying the laid down criterion.
