
OFFICE MEMORANDUM

NOTIFICATION

New Delhi, the _____, 2025

G.S.R. _____ (E).— In exercise of the powers conferred by clause (b) of sub-section (2) of section 156 of the Indo-Tibetan Border Police Force Act, 1992 (35 of 1992), the Central Government hereby makes the following rules to amend the Indo-Tibetan Border Police Force, General Duty Cadre (Group 'B' Posts) Recruitment Rules, 2024 namely :—

1. Short title and commencement.— (1) These rules may be called the Indo-Tibetan Border Police Force, General Duty Cadre (Group 'B' Posts) Recruitment (Amendment) Rules, 2025.

(2) They shall come into force on the date of their publication in the Official Gazette.

2. In the Indo-Tibetan Border Police Force, General Duty Cadre (Group 'B' Posts) Recruitment Rules, 2024 (hereinafter referred to as the said rules), after rule 3, the following shall be inserted, namely:-

“**3A. Seniority** .— The seniority of direct entrants shall be determined by adding together the marks obtained by them in the recruitment test and the basic professional course in the ratio of 50:50.”

3. In the said rules, **in the Schedule**,- against serial number 2 relating to the post of Sub-Inspector (General Duty), in column (10)- in the existing entries, the following shall be substituted, namely:-

“(i) fifty per cent by promotion, failing which by deputation
For Ex-servicemen: Deputation or re-employment.

(ii) fifty per cent by direct recruitment through Staff Selection Commission.”
