



The Deputy Commandant (Engr), 17th Bn, ITB Police Force, Reckong Peo, Dist- Kinnaur (HP) on behalf of the President of India invites online Item rate tender from approved and eligible firms/contractors of CPWD, MES, Railway, BRO, State PWD (B&R) and BSNL registered under Building construction category in appropriate class for the following work(s): -

- The enlistment of the contractors should be valid on the last date of submission of tenders. In case, the last date of submission of tender is extended, the enlistment of contractor should be valid on the original date of submission of tenders.
- The intending bidder must read the terms and conditions of **Tender form** carefully. He should only submit his bid if he considers himself eligible and he is in possession of all the documents required.
- Information and Instructions for bidders posted on website shall form part of bid document.
- The Bid Document as uploaded can be viewed and downloaded free of cost by anyone including intending bidder. But the bid can only be submitted after uploading the mandatory scanned documents.
- After submission of the bid the contractor can re-submit revised bid any number of times but before last time and date of submission of bid as notified.
- While submitting the revised bid, contractor can revise the rate of one or more item(s) any number of times (he need not re-enter rate of all the items) but before last time and date of submission of bid as notified.
- When bids are invited in two stage system and if it is desired to submit revised financial bid then it shall be mandatory to submit revised financial bid. If not submitted then the bid submitted earlier shall become invalid.
- On opening date, the contractor can login and see the bid opening process.
- The bid document consisting of plans, specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other

necessary documents can be seen and downloaded from website www.eprocure.gov.in & www.itbp.gov.in.

10. But the bid can only be submitted after deposition of original EMD either in the office of **Commandant, 17th Bn, ITB Police Force, Reckong Peo (HP)** or any location of ITBP within the period of bid submission and uploading the mandatory scanned documents such as Demand draft or Account Payee Banker's Cheque or Fixed Deposit Receipts or Pay Order/ and Bank Guarantee from any of the scheduled Bank towards EMD in favour of **Commandant, 17th Bn, ITB Police Force, Reckong Peo (HP)** as mentioned in NIT, receipt for deposition of original EMD to any location of ITBP within the period of bid submission and other documents as specified.

11. Those contractors not registered on the website mentioned above, are required to get registered beforehand. If needed, they can be imparted training on online bidding process as per details available on the website.

12. The intending bidder must have valid class-III digital signature to submit online bid.

13. **Bidder should not have past track record of delaying works.**

14. On opening date, the contractor can login and see the bid opening process. After opening of bids, he will receive the competitor bid sheets.

15. Contractor can upload documents in the form of JPG format and PDF format.

16. Contractor must ensure to quote rate in the prescribed column(s) meant for quoting rate in figures appears in yellow colour and the moment rate is entered, it turns sky blue. In addition to this, while selecting any of the cells a warning appears that if any cell is left blank the same shall be treated as "0". Therefore, if any cell is left blank and no rate is quoted by the bidder, rate of such item shall be treated as "0" (ZERO). However, If a tenderer quotes nil rates against each item in item rate tender or does not quote any Percentage above/below on the total amount of the tender or any section / sub head in percentage rate tender, the tender shall be treated as invalid and will not be considered as lowest tenderer.

17. The required documents meeting the criteria to qualify as "approved and eligible" contractors of CPWD, MES, Railway, BRO, State PWD (B&R) & Telecom/BSNL Deptt. etc along with other documents as mentioned under Para "List of Documents to be scanned and uploaded by the agency and hard copies received subsequently" shall be checked first, while opening the bid. The financial bid of only those agencies shall be opened who are found to be eligible agencies, as per this NIT.

18. The department reserves the right to reject any prospective application without assigning any reason and to restrict the list of qualified contractors to any number deemed suitable by it, if too many bids are received satisfying the laid down criterion.

19. List of Documents to be scanned and uploaded within the period of bid submission:

- i). Self-attested copy of Demand Draft/ Account Payee Banker's Cheque / FDR/Pay Order/ Bank Guarantee of any scheduled Bank against EMD.
- ii). Self-attested copy of Enlistment Order of the Contractor in CPWD, MES, Railways, BRO, BSNL and State PWD (B&R) in appropriate class.
- iii). Self-attested copy of Certificates of Work in Building or Road works.
- iv). Self-attested copy of PAN Card.
- v). Self-attested copy of GST Registration Certificate if already obtained by the bidder.

If the bidder has not obtained GST registration in the state in which the work is to be taken up, then he shall scan and upload following under taking along with bid documents.

"If work is awarded to me, I/we shall obtain GST registration certificate, as applicable, within one month from the date of receipt of award letter or before release of any payment by 17th Bn, ITBP, whichever is earlier, failing which I/we shall be responsible for any delay in payments which will be due towards me/us on account of the work executed and/or for any action taken by 17th Bn, ITBP or GST department in this regard".

- vi). Income tax clearance of last financial year.
- vii). Self-attested copy of EPFO No. if already obtained by the bidder.

If the bidder has not obtained EPFO No, then he shall scan and upload following under taking along with bid documents.

"If work is awarded to me, I/we shall obtain EPFO No, as applicable, within one month from the date of receipt of award letter or before release of 1st RA Bill by 17th Bn, ITBP, whichever is earlier, failing

which I/we shall be responsible for any delay in payments which will be due towards me/us on account of the work executed and/or for any action taken by 17th Bn, ITBP or EPFO department in this regard".

- viii). Tender form duly signed.
- ix). Copy of satisfactory completion of works of requisite magnitude from respective authorities not below the rank of Executive Engineer during last 7 years and works in progress as per given format.
- x). Solvency certificate of min amount equal to 40% of the estimated cost put to bid.
20. **Payment of cost of Tender documents:** -The collection of cost of Tender documents is dispensed away with, as there is no physical supply of tender documents and also to have absolute anonymity of the bidders participating in e-procurement solution. The bidders can view/download the tender documents, from the www.eprocure.gov.in & www.itbp.gov.in
21. **Submission of bids:** The bidders who are desirous of participating in 'e' procurement shall submit their price bids in the standard formats prescribed in the Tender documents, displayed at www.eprocure.gov.in & www.itbp.gov.in. The bidder should upload the scanned copies of all the relevant certificates, documents etc., on the www.eprocure.gov.in in support of their price bids. The bidder shall sign on all the statements, documents, certificates uploaded by him, owning responsibility for their correctness/authenticity.
22. **Price Bid Opening:-**The Price Bids will be opened online at specified date & time and the result will be displayed on the www.eprocure.gov.in which can be seen by all the bidders who participated in the tenders.
23. **Processing of Tenders:** The concerned officer/officers will evaluate and process the tenders as done in the conventional tenders and will communicate the decision to the bidder online.
24. **Participation of Bidders at the time of opening of bids:** Bidders have two options to participate in tendering process at the time of opening of Bids:
- i) Bidders can come to the place of opening of bids.
- ii) Bidders can see the process online.
25. **Signing of agreement:** After the award of the contract, an agreement shall be signed by successful bidder.
