





vii	Detail of turnover of last 3 years.
viii	The bidder should have a Banker's certificate from a Commercial Bank for 40% of ECPT (Estimated Cost Put to Tender) certified by his Bankers. (Not required if applicant is a CPWD registered contractor of appropriate class) or the bidder should submit Net worth Certificate of minimum 10% of ECPT issued by the certified Chartered Accountant.
ix	Affidavit as per form-D for non-debar from any Government, Semi Government organizations.

**Note :** Bidder should ensure himself that above documents are uploaded in correct format and at correct location on the website.

6. Earnest Money of Rs 25,122/- in form of Banker's cheque or Demand Draft or Fixed Deposit or Bank Guarantee receipt of any scheduled bank in favour of Dy Inspector General, SHQ BBSR, ITBP and deposit original EMD either in the office of Dy Inspector General, SHQ BBSR, ITBP or any formation of ITBP within period of bid submission time. Receipt of EMD obtained from the concerned Engineering branch of the formation of ITBP where EMD have been submitted, to be scanned and uploaded to the e-tendering website at the time of bid submission. (Format of receipt placed at page no. 44 of tender form.)
7. If EMD is not deposited in physical form by due date and time in mentioned address or any office/formation of ITBP, technical bid of that firm will not be accepted and it will not be placed under shortfall.
8. Those contractors not registered on the website mentioned above, are required to get registered beforehand. If needed, they can be imparted training on online bidding process as per details available on the website.
9. The intending bidder must have valid class-III digital signature to submit online bid.
10. Bidder should not have past track record of delaying works with compensation as per documents provided.
11. On opening date, the contractor can login and see the bid opening process. After opening of bids he will receive the competitor bid sheets.
12. Contractor can upload documents in the form of JPG format or PDF format.
13. Contractor must ensure to quote rate of each item, if any cell is left blank and no rate is quoted by the tenderer, rate of such item shall be treated as "0" (ZERO). However, if tenderer quotes Nil rates against each item in item rate tender or does not quote any percentage above/below on the lowest amount of the tender or any section/sub head in percentage rate tenders, the tender shall be treated as invalid and will not be considered as lowest tender.
14. The required documents meeting the criteria to qualify as "approved and eligible" contractors of CPWD, MES, Railway, State PWD & Telecom/BSNL Dept. along with other documents as mentioned under Para "List of Documents to be scanned and uploaded by the agency and hard copies received subsequently" shall be checked first, while opening the bid. The financial bid of only those agencies shall be opened who are found to be eligible agencies, as per this NIT.


