(a) Bid document duly stamped and signed on all pages.

(b) copy of GST Registration Certificate.

(c) copy of latest ITR(2020-21 and 2021-22)

(d) copy of latest/up to date Valid Trading License/Firm registration in English/Hindi issued by competent authority. If the Trading License is expiring during the contractual period the bidders should submit an affidavit for renewal of trading license.

(e) Financial Stability Certificate/Solvency Certificate issued during current financial year form commercial to the fact that no chemical is issued for pending of goods & to make goods look fresh.

(f) scanned copy of ECS Mandate form.

(g) Tender sample clause:-

A separate B.O.O will be constituted for inspection of sample. This boards is fully competent to rejects any firm on the basis of its samples. For this purpose tenderers should have tender samples readily available. The tenderers who are participating in this tender are required to display the samples of all the items as per the schedule in front of constituted BOO after opening of bid, free of cost on "no cost no commitment basis" on the intimated date.
