- 5) All Firms who are not registered with DGS&D/NSIC for the specification of subject store shall be required to deposit Earnest money as mentioned above along with tender forms.
- 6) All firms are to be deposited original copy of EMD and tender sample at the SM office of RTC KARERA (ADM BLOCK ), ITB POLICE, before bid submission closing date and time.
- 7) Following certificates are also required for submission of E-Bids.

  - iii) Turn over/ Bank balance statement/bank cheque.
  - iv) ITR for previous three years.
  - v) Latest GST clearance certificate.
  - vi) RTGS/ NEFT mandate form.
  - vii) And any other relevant document as per tender documents & annexures and which the firm wishes to submit.(Documents should be valid for the period of tender)
