1. Contractors/Firms who fulfill the following requirements shall be eligible to apply:- Joint Ventures are not accepted.
  - a) Should have completed satisfactorily at least \*3(three) similar works each of value 40% of the estimated cost or \*2(two) similar works of 60% of the estimated cost or \*1(one) similar work of 80% of estimated cost during the last 7(seven) years (at least one work of them should be in Central Govt /Central Autonomous bodies/ Central PSU/State Govt). **"Similar work shall mean Regeneration , installation , Servicing , Operation and maintenance of off grid solar power plants"**
  - b) Should have experience in installation, servicing and maintenance of solar power plants in high altitude Region or different terrain in Himalaya region.
  - c) Should have had Average Annual Financial Turnover of at least 50% of the estimated cost put to tender on solar energy works during the last three years ending 31st March 2022(Scanned copy of Certificate from CA to be uploaded).

- d) Should have solvency equal to 40% of the estimated cost put to tender (Scanned copy of Certificate to be uploaded).
- 2- The intending bidder must read the terms and conditions of CPWD-6 carefully. He should only submit his bid if he considers himself eligible and he is in possession of all the documents required.
  - 3- Bid can only be submitted after deposition of original EMD . EMD in the form of Treasury Challan or Demand Draft or Pay order or Banker's Cheque or Deposit at Call Receipt or Fixed Deposit Receipt drawn in favour of **The Commandant 15<sup>th</sup> Bn , ITBP , Udhmapur** and shall be scanned and uploaded to the e-Tendering website within the period of bid submission. The bidder will ensure that physical Earnest Money deposit (original) is deposited in the office of The Assistant Commandant (Engineer) , 15<sup>th</sup> Bn , ITBP , PO- Garhi , Udhampur (J&K)-182121as per prescribed date and time, else bid will be rejected as unresponsive bid.
  - 4- Those bidders not registered on the website mentioned above, are required to get registered beforehand. If needed, they can be imparted training on online bidding process as per details available on the website.
  - 5- The intending bidder must have valid class-I/Class-II/Class-III digital signature to submit the bid.
  - 6- The documents can be seen and downloaded from website [www.eprocure.gov.in](http://www.eprocure.gov.in) & [www.itbp.gov.in](http://www.itbp.gov.in) .
  - 7- Bidder can upload documents in the form of **JPG** format and **PDF** format
  - 8- Bidder should not have past track record of delaying works.
  - 9- On opening date, the contractor can login and see the bid opening process. After opening of bids he will receive the competitor bid sheets.
  - 10- Contractor must ensure to quote percentage rate on total value of work with selection of ABOVE/ BELOW/ AT PAR. The column meant for quoting percentage rate in figures appears in "Yellow Color". In addition to this, while selecting Above/ Below / AT PAR, if the cell is left with AT PAR selection, the same shall be treated as "0" (ZERO) Percent. However, if a tenderer quotes nil rates against each item in item rate tender or does not quote any percentage above / below on the total amount of the tender or any section / subhead in percentage rate tender, the tender shall be treated as invalid and will not be considered as lowest tenderer.
  - 11- The required documents meeting the criteria to qualify as "approved and eligible" contractors/firms enlisted with CPWD, MES, Railway, BRO, State PWD& BSNL Deptt. etc along with other documents as mentioned under Para "List of Documents to be scanned and uploaded by the agency and hard copies received subsequently" shall be checked first, while opening the bid. The financial bid of only those agencies shall be opened who are found to be eligible agencies, as per this NIT.
  - 12- The department reserves the right to reject any prospective application without assigning any reason and to restrict the list of qualified contractors to any number deemed suitable by it, if too many bids are received satisfying the laid down criterion.

13- The tender can only be submitted after uploading the mandatory scanned documents as per list given below.

- i. Tender form duly signed.
- ii. Copy of contractor/ Firm Enlistment Order/ Registration in concerned department
- iii. Work experience certificate from the respective departments.
- iv. Certificate of Financial Turnover duly audited by CA
- v. Scanned copy of EMD (Original EMD also to be deposited)
- vi. Banker's Certificate or Net Worth Certificate.
- vii. Copy of PAN Card
- viii. GST registration Certificate of the State in which the work is to be taken up, if already Obtained by the bidder.

If the bidder has not obtained GST registration in the State in which the work is to be taken up or as required by GST authorities then in such a case the bidder shall scan and upload following undertaking along with other bid documents.

"If work is awarded to me, I/We shall obtain GST registration Certificate of the State, in which work is to be taken up within one month from the date of receipt of award letter or before release of any payment by ITBP, which is earlier. Failing which I/We shall be responsible for any action taken by ITBP or GST department in this regard.
