Notice Inviting e-Tender

The Assistant Commandant (Engineer) , 15thBn , ITBP , PO- Garhi , Udhampur (J&K) on behalf of the President of India invites Percentage Rate Bid from authorized service providers/firms/contractors enlisted with CPWD/ MES/ Railways/ BRO/BSNL/ State PWD and or from firms having experiences for execution of for the following work: -

1. The enlistment of the contractors should be valid on the last date of submission of tenders. In case, the last date of submission of tender is extended, the enlistment of contractor should be valid on the original date of submission of tender.
2. The intending bidder must read the terms and conditions of **Tender form** carefully. Work shall be carried out at Border Outpost of ITBP which situated at Laddakh region . The bidder should only submit his bid if he considers himself eligible and he is in possession of all the documents required.
3. The documents can be seen and downloaded from website www.eprocure.gov.in & www.itbp.gov.in .
4. The tender can only be submitted after uploading the mandatory scanned documents as per list given below.
 - i. Tender form duly signed.
 - ii. Copy of contractor Enlistment Order/ Registration in concerned department /authorized service provider of generator sets
 - iii. List of work completed as per tender document.

- iv. Work experience certificate from the respective departments.
- v. Certificate of Financial Turnover duly audited by CA (Must have Average annual financial turnover of at least 50% of the estimated cost put to tender during the immediate last three consecutive financial years for meeting the eligibility criterion).
- vi. Scanned copy of EMD (Original EMD also to be deposited).
- vii. Solvency Certificate of min amount equal to 40% of the estimated cost put to tender.
- viii. Copy of PAN Card and Latest income tax Return.
- ix. GST registration Certificate of the State in which the work is to be taken up, if already obtained by the bidder.

If the bidder has not obtained GST registration in the State in which the work is to be taken up or as required by GST authorities then in such a case the bidder shall scan and upload following undertaking along with other bid documents.

"If work is awarded to me, I/We shall obtain GST registration Certificate of the State, in which work is to be taken up within one month from the date of receipt of award letter or before release of any payment by ITBP, which is earlier. Failing which I/We shall be responsible for any action taken by ITBP or GST department in this regard."

5. The bidder will ensure physical submission of EMD in favour of The Commandant , 15thBn , ITBP Udhampur, in the form of Demand Draft, Banker Cheque/Deposit at call receipt/Fixed Deposit Receipt. Original EMD has to be deposited in the office of The Assistant Commandant (Engineer) , 15thBn , ITBP , PO- Garhi , Udhampur (J&K)-182121, as per prescribed date & time, else bid will be rejected as unresponsive bid.
6. Those bidders not registered on the website mentioned above, are required to get registered beforehand. If needed, they can be imparted training on online bidding process as per details available on the website.
7. The intending bidder must have valid class-I/Class-II/Class-III digital signature to submit the bid.
8. Bidder should not have past track record of delaying works.
9. On opening date, the contractor can login and see the bid opening process. After opening of bids he will receive the competitor bid sheets.
10. Contractor can upload documents in the form of **JPG** format and **PDF**format.
11. Contractor must ensure to quote percentage rate on total value of work with selection of ABOVE/ BELOW/ AT PAR. The column meant for quoting percentage rate in figures appears in "Yellow Color". In addition to this, while selecting Above/ Below / AT PAR, if the cell is left with AT PAR selection, the same shall be treated as "0" (ZERO) Percent. However, if a tenderer quotes nil rates against each item in item rate tender or does not quote any percentage above / below on the total amount of the tender or any section / subhead in percentage rate tender, the tender shall be treated as invalid and will not be considered as lowest tenderer.
12. The required documents meeting the criteria to qualify as "approved and eligible" contractors/service provider enlisted with CPWD, MES, Railway, BRO, State PWD& BSNL Deptt. etc or authorized services providers of Generator sets along with other documents as mentioned under Para "List of Documents to be scanned and uploaded by the agency and hard copies received subsequently" shall be checked first, while opening the bid. The financial bid of only those agencies shall be opened who are found to be eligible agencies, as per this NIT.

13. The department reserves the right to reject any prospective application without assigning any reason and to restrict the list of qualified contractors to any number deemed suitable by it, if too many bids are received satisfying the laid down criterion.
