

3. Information and Instructions for bidders posted on website shall form part of bid document.
4. The bid document consisting of plans, specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from website www.eprocure.gov.in & www.itbp.gov.in.
5. The tender can only be submitted after uploading the mandatory scanned documents as per list given below. (AS per bid document P-08 Para-23.)
 - I. Copy of valid enlistment in appropriate class.
 - II. Copy of GST registration of the state where work to be taken as per Bid document P-08, at S.No.-23 (IV).
 - III. Tender form duly signed with stamp.
 - IV. Work experience certificate.
 - V. Scanned copy of EMD and receipt of EMD as per tender document Page No-09.
 - VI. EPFO, ESIC, BOCW Welfare board, PF No, Labour Licence as per Bid document P-08 at S.No.-23 (III).
 - VII. Affidavit as per Clause 1.2.1 and 21.2A of CPWD-6.(Tender form page No 03 and 07)
 - VIII. Last Three year turn over certificate from CA as per CPWD SOP-2019/P-186 (Form-A), which is not less than Rs 136.65 lakhs per year average.
 - IX. Bank Solvency from Bank as per CPWD SOP-2019/ P-186 (form –"B") which is not less than Rs. 91.10 lakhs.
 - X. Eligibility similar nature works completed during last seven years ending 31-12-2022. As per CPWD SOP-2019/P-186 (Form-C)
6. The bidder will ensure physical submission of EMD in favor of **The Commandant, 21 Bn ITB Police, Pantha Chowk, Srinagar (Jammu and Kashmir)** in the form of Demand draft, Banker's Cheque / Deposit at call receipt/ Fixed Deposit Receipt and payable at Srinagar (J & K.)
7. The intending tenderer has to fill all the details such as Banker's name, Demand Draft/Fixed Deposit Receipt /Pay Order/ Banker's Cheque/Bank Guarantee number, amount and date. The amount of EMD can be paid by multiple Demand Draft / Pay Order / Banker's Cheque / Deposit at call receipt / Fixed Deposit Receipts -A part of earnest money is acceptable in the form of bank guarantee also. In such case, 50% of earnest money or Rs. 20 lac, whichever is less, will have to be deposited in shape prescribed above, and balance in shape of Bank Guarantee of any scheduled bank.
8. Those contractors not registered on the website mentioned above are required to get registered beforehand. If needed, they can be imparted training on online bidding process as per details available on the website.
9. The intending bidder must have valid class-III digital signature to submit online bid.
10. Bidder should not have past track record of delaying works.
11. On opening date, the contractor can login and see the bid opening process. After opening of bids he will receive the competitor bid sheets.
12. Contractor can upload documents in the form of JPG format and PDF format
13. Contractor must ensure to quote rate of each item if any cell is left blank and no rate is quoted by the tenderer rate of such item shall be treated as 0 (ZERO). However if tenderer quotes Nil rates against each item in item rate tender or does not quote any percentage above/below on the lowest amount of the tender or any section/sub head in percentage rate tenders the tender shall be treated as invalid and will not be considered as lowest tender.
