- 3. - 6. Those contractors not registered on the website mentioned above, are required to get registered beforehand. If needed, they may get training on online bidding process as per details available on the
- 7. The intending bidder must have valid class-III digital signature to submit the bid.
- 8. Bidder should not have past track record of delaying works. Bids of having record of past unsatisfactory work/poor workmanship will be rejected.
- 9. On opening date, the contractor can login and see the bid opening process. After opening of bids he will receive the competitor bid sheets.
- 10. Contractor can upload documents in the form of JPG format and PDF format.
- 11. Contractor must ensure to quote rate of each item. The column meant for quoting rate in figures appears in pink colour and the moment rate is entered, it turns sky blue. In addition to this, while selecting any of the cells a warning appears that if any cell is left blank the same shall be treated as "0". Therefore, if any cell is left blank and no rate is quoted by the tenderer, rate of such item shall be treated as "0" (ZERO). However, if tenderer quotes Nil rates against each item in item rate tender or does not quote any percentage above/below on the lowest amount of the tender or any section/sub head in percentage rate tenders, the tender shall be treated as invalid and will not be considered as lowest tender.
