- 5) All Firms who are not registered with DGS & D/NSIC for the specification of subject store shall be required to deposit Bank Draft (Earnest money) as mentioned above along with tender forms.
- 6) All firms are to be deposited original copy of Bank Draft (EMD) and tender sample at the SM office of RTC Karera (ADM BLOCK), ITB Police, before bid submission closing date and time.
- 7) Following certificates are also required for submission of E-Bids.
 - i) Certificate of registration from food safety administration for supply of above Fresh ration items.
 - ii) Food safety certificate.
 - iii) Certificate of registration of firm from concerned district labour office.
 - iv) Technical documents viz. registration certificate.
 - v) PAN Card.
 - vi) Aadhar card (Address proof).
 - vii) GST Certificate.
 - viii) Bank Cheque (Turnover/Bank balance statement).
 - ix) ITR for previous three years.
 - x) Latest GST clearance certificate.
 - xi) RTGS/ NEFT mandate form duly attested by the bank.
 - xii) Experience certificate previous three years.
 - xiii) Bank Draft in original (EMD).
 - xiv) Tender sample in one KG each items.
