The Second In Command (Engineer) , SHQ Srinagar ITB Police Force , Panthachowk Srinagar, on behalf of the President of India invites online **Percentage rate tender** in two bid system from approved and eligible firms / contractors of CPWD/Any Other Central Government Agencies/ State PWD/ MES/ Railway/ BSNL/ BRO/Irrigation and Flood control J&K / State Govt Agencies / Govt. PSUs registered under Civil (Building/PHE/Sanitary) construction category in appropriate class for the following works:-

1. The enlistment of the contractors should be valid on the last date of submission of tenders. In case, the last date of submission of tender is extended, the enlistment of contractor should be valid on the original date of submission of tenders.
2. The intending bidder must read the terms and conditions of Tender form carefully. He should only submit his bid if he considers himself eligible and he is in possession of all the documents required.
3. Information and Instructions for bidders posted on website shall form part of bid document.

4. The bid document consisting of plans, specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and all necessary documents can be viewed and downloaded from website www.eprocure.gov.in & www.itbp.gov.in.
5. The tender can only be submitted after uploading the mandatory scanned documents as per list given below. (AS per bid document P-08 Para-24.)
 - I. Copy of valid enlistment in appropriate class.
 - II. Copy of GST registration of the state where work to be taken as per Bid document P-08, at S.No.-24 (VII).
 - III. Tender form duly signed with stamp.
 - IV. Work experience certificates.
 - V. Scanned copy of EMD and receipt of EMD as per tender document Page No-09.
 - VI. Affidavit as per Clause 1.2.3 of CPWD-6. (language as per P-03 of NIT)
 - VII. Last Three year turn over certificate from CA as per CPWD SOP-2022/P-202 (Form-A) (Form at P-60 of NIT), which is not less than 30 % of tender Cost (Rs. 25.67 Lakh).
 - VIII. Bank Solvency from Bank as per CPWD SOP-2022/ P-203 (Form –“B”) (Form at NIT Page No-60 Form ‘B’) which is not less than 40% of tendered cost (Rs. 34.22 lakh) . or Net worth certificate as per CPWD SOP-2022/P-203 (Form B-1) (NIT page No:- 60 Form B-1) which is minimum 10 % (Rs. 8.56 Lakh) of the estimated cost put to tender from Chartered accountant (CA)
 - IX. Eligibility similar nature works completed during last seven years ending 31-03-2024. As per CPWD SOP-2022/P-204 (Form-C) or tender form,P-61,Form - C.
 - X. Bidding capacity as per CPWD SOP-2022/P-205 Form ‘C-3’ or NIT page No-61, Form-‘C-3’.
6. The bidder will ensure physical submission of EMD in favor of “**Commandant 15th Bn ITB Police, Udhampur (J&K)**” in the form of Demand draft, Banker's Cheque / Deposit at call receipt/ Fixed Deposit Receipt and payable at Udhampur (J&K) at any place of India in ITBP as per page No-09 of NIT..
7. The intending tenderer has to fill all the details such as Banker's name, Demand Draft/Fixed Deposit Receipt /Pay Order/ Banker's Cheque/Bank Guarantee number, amount and date. The amount of EMD can be paid by multiple Demand Draft / Pay Order / Banker's Cheque / Deposit at call receipt / Fixed Deposit Receipts -A part of earnest money is acceptable in the form of bank guarantee also. In such case, 50% of earnest money or Rs. 20 lac, whichever is less, will have to be deposited in shape prescribed above, and balance in shape of Bank Guarantee of any scheduled bank.
8. Those contractors not registered on the website mentioned above, are required to get registered beforehand. If needed, they can be imparted training on online bidding process as per details available on the website.



9. The intending bidder must have valid class-III digital signature to submit online bid.
10. Bidder should not have past track record of delaying works.
11. On opening date, the contractor can login and see the bid opening process. After opening of bids he will receive the competitor bid sheets.
12. Contractor can upload documents in the form of JPG format and PDF format.
13. Contractor must ensure to quote rate of each item, if any cell is left blank and no rate is quoted by the tenderer, rate of such item shall be treated as "0" (ZERO). However, if tenderer quotes Nil rates against each item in item rate tender or does not quote any percentage above/below on the lowest amount of the tender or any section/sub head in percentage rate tenders, the tender shall be treated as invalid and will not be considered as lowest tender.
14. The required documents meeting the criteria to qualify as "approved and eligible" contractors of CPWD, MES, Railway, State PWD & Telecom/BRO/BSNL Deptt. etc along with other documents as mentioned under Para "List of Documents to be scanned and uploaded by the agency and hard copies received subsequently" shall be checked first, while opening the bid. The financial bid of only those agencies shall be opened who are found to be eligible agencies, as per this NIT.
15. The department reserves the right to reject any prospective application without assigning any reason and to restrict the list of qualified contractors to any number deemed suitable by it, if too many bids are received satisfying the laid down criterion.
