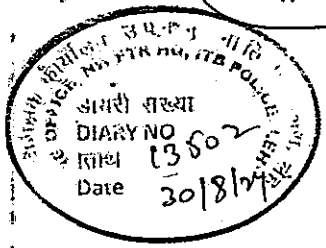

Notice Inviting e-Tender

The Second-In-Command (Engr), SHQ (Delhi) ITB Police PO- Madangir, New Delhi-110062 on behalf of the President of India invites online Percentage rate e-bids in two bid system from approved and eligible firms/contractors of CPWD, MES, Railway, BRO, and State PWD, registered under Road works in appropriate class for the work: **Re-carpeting of Internal road of campus at 28th Bn, ITBP, Jatusansa, Rewari (HR).**

- The enlistment of the contractors should be valid on the last date of submission of tenders. In case, the last date of submission of tender is extended, the enlistment of contractor should be valid on the original date of submission of tender.
- The intending bidder must read the terms and conditions of **Tender form** carefully. He should only submit his bid if he considers himself eligible and he is in possession of all the documents required.
- Information and Instructions for bidders posted on website shall form part of bid document.
- The bid document consisting of plans, specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from website www.eprocure.gov.in & www.itbp.gov.in.
- The tender can only be submitted after uploading the mandatory scanned documents as per list given below.
 - Scanned copy of Tender form duly signed.
 - Scanned Copy of valid enlistment in appropriate class.
 - Copy of PAN card, Registration certificate of EPFO, ESIC and PF No
 - Scanned copy of Work experience certificate. Work Experience Certificate:- Certificate of eligible similar nature of works completed (including BOQ of Final bill) during the last seven years ending previous day of last day of submission of tenders issued by an officer not below the rank of Deputy Commandant (Engr.) /EE/ Project manager or equivalent. Full credentials of the project authorities e.g. e-mail ID, complete postal address, Phone no. etc. are required for verification purposes. If private works are shown in support of eligibility, certified copy of the tax deducted at source certificate (TDS), G.S.T deposited in the State where the work is executed, shall be submitted along with the experience certificate and the T.D.S. amount shall tally with the actual amount of work done. Works executed outside India shall not be considered as eligible works.

- e) Certificate of Financial Turnover of last 03 years duly audited by CA (Must have Average annual financial turnover of at least 50% of the estimated cost put to tender during the immediate last three consecutive financial years for meeting the eligibility criterion).
- f) Demand Draft/Pay order or Banker's Cheque /Deposit at Call Receipt/FDR/ Bank Guarantee of any Scheduled Bank against EMD in favour of "DIG SHQ DELHI, ITBP" along with receipt of deposit of EMD in any of ITBP formation.
- g) Valid GST Registration Certificate.

6. Valid GST Registration Certificate of the State in which the work is to be taken up if already obtained by the bidder.

"If work is awarded to me, I/we shall obtain GST registration Certificate of the State, in which work is to be taken up, within one month from the date of receipt of award letter or before release of any payment by ITBP, whichever is earlier, failing which I/We shall be responsible for any delay in payments which will be due towards me/us on a/c of the work executed and/or for any action taken by ITBP or GST department in this regard.

7. "Submission Of EMD in physical form in any of ITBP Formation. The bidder has to mandatorily upload scanned copy of EMD with copy of Receipt issued by EMD receiving formation along with other documents prescribed in NIT, as per prescribed date & time; else bid will be rejected as unresponsive bid.
8. Those contractors not registered on the website mentioned above, are required to get registered beforehand. If needed, they can be imparted training on online bidding process as per details available on the website.
9. The intending bidder must have valid class-III digital signature to submit online bid.
10. Bidder should not have past track record of delaying works.
11. On opening date, the contractor can login and see the bid opening process. After opening of bids he will receive the competitor bid sheets.
12. Contractor can upload documents in the form of JPEG format and PDF format.
13. Contractor must ensure to quote rate of each item, if any cell is left blank and no rate is quoted by the tenderer, rate of such item shall be treated as "0" (ZERO). However, if tenderer quotes Nil rates against each item in item rate tender or does not quote any percentage above/below on the lowest amount of the tender or any section/sub head in percentage rate tenders, the tender shall be treated as invalid and will not be considered as lowest tender.
14. The required documents meeting the criteria to qualify as "approved and eligible" contractors of CPWD, MES, Railway, BRO, and State PWD along with other documents as mentioned under Para "List of Documents to be scanned and uploaded by the agency and hard copies received subsequently" shall be checked first, while opening the bid. The financial bid of only those agencies shall be opened who are found to be eligible agencies, as per this NIT.
15. Only technically qualified firms will be entertained in financial bid opening.
16. The department reserves the right to reject any prospective application without assigning any reason and to restrict the list of qualified contractors to any number deemed suitable by it, if too many bids are received satisfying the laid down criterion.
