**Notice Inviting e-Tender**

The Asstt Commandant (Engr), 28th Bn I.T.B Police, on behalf of the President of India inviting online Percentage Rate Bids from approved and eligible CPWD/ State Department /Railway/MES/BSNL/BRO enlisted contractors of appropriate class in civil /composite work in two bid system for the following work-

- Contractors who fulfil the following requirements shall be eligible to apply. The intending contractors should have satisfactorily completed the works as mentioned below during the last seven years ending last day of the month previous to the one in which tenders are invited .  
Three similar works each costing not less than 40% of estimated cost or two similar works each costing not less than 60% of estimated cost or one similar work costing not less than 80%. The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7 % per annum, calculated from the date of completion to previous day of last day of submission of tender.
  - Should have had average annual financial turnover of 30 % of estimated cost put to tender on construction works during the last three years ending 31<sup>st</sup> March of preceding year(Scanned copy of certificate from CA with unique documents identification Number (UDIN) to be uploaded.) The value of annual turnover figures shall be brought to the current value by enhancing the actual turnover figures at simple rate of 7% per annum.
  - Should not have incurred any lose (Profit after tax should be positive) in more than two years during the last five years ending 31<sup>st</sup> March of preceding year .
  - Should have a bankers certificate from a commercial bank for 40 % of estimated cost put to tender) or net worth certificate from CA with unique documents identification Number (UDIN) of minimum 10% amount of estimated cost put to tender (scanned copy of original to be uploaded)
- The intending bidders must read the terms and conditions of CPWD-6 carefully. He should only submit his bid if he considers himself eligible and he is in possession of all the documents required.
  - This information and instructions for bidders posted on website shall form Pay of bid document.
  - The bid documents consisting of plans, specifications, the schedule of quantities of various types of items /works to be executed and the set of terms and conditions of the contract to be complied with and other

- necessary documents can be seen and down loaded from the CPP Portal [www.eprocure.gov.in](http://www.eprocure.gov.in) & also be seen on the website [www.itbpolice.nic.in](http://www.itbpolice.nic.in).
4. But the bid can only be submitted after deposition of original EMD in any of ITBP formation within the period of bid submission and uploading the mandatory scanned documents such as demand draft or pay order or banker's cheque or deposit at call receipt or fixed deposit receipt and bank guarantee including e-bank guarantee from any of the commercial bank towards EMD in favour of Commandant, 28<sup>th</sup> Bn ITBP as mentioned in NIT, receipt for depositing of original EMD to any of ITBP formation.
  5. Those contractors who are not registered or have not updated their profile on the website mentioned above are required to get registered/ update their profile beforehand. The necessary training material including the videos with step to step process are available on download section of [www.eprocure.gov.in](http://www.eprocure.gov.in).
  6. The intending bidder must have valid class-III digital signature certificate with encryption key (Combo Type) to perform any operation / transactions on the e-tendering portal / website and the bidder should download and install the e signer on their system as per instruction available on download section of [www.eprocure.gov.in](http://www.eprocure.gov.in)
  7. On opening date, the contractor can login and see the bid opening process. After opening of bids he will receive the competitor's bid sheets.
  8. Contractor can upload documents in the form of JPG format and PDF format.
  9. Certificate of financial turnover-At the time of submission of bid contractor may upload Affidavit/Certificate from CA mentioning financial turnover of last seven years or for the period as specified in the bid documents and further details if required may be asked from the contractor after opening of technical bids. There is no need to upload voluminous balance sheet.
  10. If a tenderer quotes NIL rates or does not quote any percentage above or below on the total amount of the tender or any section / sub head in percentage rate tender, the tender shall be treated as invalid and will not be considered as lowest tenderer.
  11. The technical bid shall be opened first on due date and time as mentioned above. The time and date of opening of financial bid of contractors qualifying the technical bids shall be communicated to them at a later date.
  12. Clarifications required (if any) may be obtained through CPP portal.
  13. When bids are invited in three stage system and if it is desired to submit revised financial bid then it shall be mandatory to submit revised financial bid. If not submitted then the bid submitted earlier shall become invalid.

14. **List of documents to be scanned and uploaded within the period of bid submission:**

(i)	Copy of receipt for deposition of original EMD in any of ITBP formation with copy of EMD
(ii)	Certificates of work experience-in format (Form-C, Form-C1) CPWD SOP -2022 (P-59)
(iii)	Affidavit as per Clause 1.2.1 (IV) of CPWD-6 form
(iv)	GST Registration Certificate, if already obtained by the bidder. If the bidder has not obtained GST registration in the state in which the work is to be taken up, then in such a case the bidder shall upload following undertaking with the bid document "If work is awarded to me, I/we shall obtain GST registration Certificate of the State as applicable, in which work is to be taken up, within one month from the date of receipt of award letter or before release of any payment by ITBP, whichever is earlier, failing which I/We shall be responsible for any delay in payments which will be due towards me/us on a/c of the work executed and/ or for any action taken by ITBP or GST department in this regard."
(v)	Enlistment order from CPWD/ State Departments/ Railway/MES/BSNL/BRO contractors in appropriate class in composite category.
(vi)	Banker's Certificate of the amount equal to 40% of the Estimated Cost put to tender (ECPT) as per CPWD2022 SOP format (Form-B,P-203) Or Networth atleast 10% amount certificate from CA (Ref CPWD2022 SOP (Form-B-1,P-203)
(vii)	Last three years turn over ( at least 30.% of estimated cost put to tender ).
(viii)	Undertaking from contractor in his/their letter head (with valid address, E-mail id, phone nos) that he/they agreed to execute work complying all terms and conditions in tender document.
