

4. But the tender can only be submitted after uploading the mandatory scanned documents as per list given below.
5. To become eligible for acceptance of bid, the bidders shall have to furnish an affidavit as under: -

Further that, if such a violation comes to the notice of Department, then I/we shall be debarred for bidding in ITBP in future forever. 6. Those contractors not registered on the website mentioned above, are required to get registered beforehand. If needed, they may get training on online bidding process as per details available on the website.

7. The intending bidder must have valid class-III digital signature to submit the bid.

8. Bidder should not have past track record of delaying works. Bids of having record of past unsatisfactory work/poor workmanship will be rejected.

9. On opening date, the contractor can login and see the bid opening process. After opening of bids, he will receive the competitor bid sheets.

10. Contractor can upload documents in the form of JPG format and PDF format.

11. Contractor must ensure to quote rate of each item. The column meant for quoting rate in figures appears in pink colour and the moment rate is entered, it turns sky blue.

In addition to this, while selecting any of the cells a warning appears that if any cell is left blank the same shall be treated as "0".
