

 - II. Copy of GST/PAN registration.
 - III. Tender form duly signed by Contractor.
 - IV. List of work completed as per tender document.
 - V. Scanned copy of EMD or "**Bid Security Declaration**" along with registration certificate under Micro and small enterprises whatever case may be.
 - VI. Income tax return filing certificate of last three year or Income tax exemption certificate as the case may be.
