- a) **The consultancy services enlistment of the bidder should be valid on the last date of submission of tender.** In case, the last date of submission of tender is extended, the enlistment of consultancy firm should be valid on the original date of submission of tender's.
- b) Proprietor or one of the partner or one of the Director of the firm/consultant must be Architects (Minimum Qualification Bachelor of Architecture at least with 5 Years Experience) or structural engineer (Minimum Qualification M. Tech at least with 5 Years Experience) with valid registration from **Council of Architecture and Institute of Engineers (India)** respectively.
- c) Average Annual Financial Turnover on Architectural/ Engineering Consultancy works during the last three years, ending 31st March of the previous financial year i.e. 2023-24 should be at least 5.00 Lakh.(30% of the estimated value) (Documentary evidence needs to be submitted). - d) Agency have to submit the solvency certificate of amount equal to 40% of the estimated cost put to tender. AS per CPWD SOP 2024 Page No 214 Form -B


- e) Consultancy fee received from Architectural/ Engineering Consultancy work from a single project during last three years, ending 31st March of the previous financial year i.e. 2023-24 should be at least 5.00 lakh. (Documentary evidence is needs to be submitted). To bring up to the current year the turnover shall be calculated with 7% compounding each year.
- f) Agency must have successfully completed the consultancy work for a RCC buildings with Electrical, Water supply, Sanitary, HVAC, Firefighting etc. all complete work of a RCC Permanent buildings **at least one work of 80% of estimated cost or two work of 60% of estimated cost or three work of 40% of estimated cost in last 07 years** of any Central/ Sate Government Deptt./ Central Public sector/ State Public sector Undertaking/Central Autonomous body. / State Autonomous body/City Development authority/ Municipal Corporation of city formed under any act by central/State Government and published in Central/State gazette/listed public/private limited company. 

7. For complete details refer website [www.eprocure.gov.in](http://www.eprocure.gov.in) at CPP portal or ITBP website [www.itbp.gov.in](http://www.itbp.gov.in), on opening date of the financial bid, which can be intimated after the screening process of technical bid, the bidders can login and see the bid opening process. After opening of financial bids, he will receive the competitor's bid sheet.
8. Bidders can upload documents in the form of JPG format or PDF format.
9. **Bidders should not have past record of delaying works.**
10. Any change /modification in tender enquiry will be intimated through above mentioned websites only.
