- e. Receipt of deposition of EMD in form of Treasury Challan/Demand Draft/Pay order or Banker's Cheque /Deposit at Call Receipt/FDR/ Bank Guarantee any Scheduled Bank in any of ITBP formation office. Along with photocopy of EMD.
- f. ESIC Registration or exemption notice as applicable or affidavit to submit the proof of applying these within 15days from date of issue of acceptance of letter.
- g. EPF Registration/ or affidavit to submit the proof of applying these within 15 days from date of issue of acceptance of letter.

6. The bidder will ensure physical submission of EMD in favour of the DY. INSPECTOR GENERAL SHQ (LKB) ITB POLICE, ARUNACHAL PRADESH in the form of Demand Draft, Banker's Cheque /Deposit at Call Receipt/Fixed Deposit Receipt. at any of the office of ITBP and will obtain receipt of same for uploading in CPP Portal along with copy of EMD. EMD exemption (i.e. MSME certificate etc) is not allowed.

7 The intending tenderer has to fill all the details such as Banker's name Demand Draft/Fixed Deposit Receipt /Pay Order/Banker's Cheque/ Bank Guarantee number amount and date. The amount of EMD can be paid by multiple Demand Draft/Pay Order/ Banker's Cheque/ Deposit at Call receipt/Fixed Deposit Receipts. A part of earnest money is acceptable in the form of Bank Guarantee also. In such case 50% of earnest money or Rs 20 lac whichever is less will have to be deposited in shape prescribed above and balance in shape of bank guarantee of any scheduled bank.

8 Those contractors not registered on the website mentioned above, are required to get registered beforehand. If needed they can be imparted training on online bidding process as per details available on the website.

9 The intending bidder must have valid class III digital signature to submit online bid.

10 On opening date the contractor can login and see the bid opening process after opening of bids he will receive the competitor bid sheets.

11 Contractors can upload documents in the form of JPG format and PDF format.

13 Contractor must ensure to quote rate If Tenderer does not quote any percentage above/below amount of the tender or any section/sub head in percentage rate tenders, the tender shall be treated as invalid and will not be considered as lowest tender.

14 The required documents meeting the criteria to qualify as "approved and eligible" contractors of CPWD, MES, Railway, State PWOs & Telecom/BSNL Deptt. etc along with other documents as mentioned under paras"List of documents to be scanned and uploaded by the agency shall be checked first, while opening the bid the financial bid of only those agencies shall be opened who are found to be eligible agencies, as per this NIT.
