The Asst. Commandant Engineer, 48th BN, ITBP on behalf of President of India invites Online Percentage rate tenders in Two bid system from approved and eligible contractors of CPWD, MES, Railway, BRO, and State's PWD, PHE registered under Building construction/composite category in appropriate category and class for the following work.

- The enlistment of the contractors should be valid on the last date of submission of tenders. In case, the last date of submission of tender is extended, the enlistment of contractor should be valid on the original date of submission of tenders.
- The intending bidder must read the terms and conditions of **Tender form** carefully. He should only submit his bid if he considers himself eligible and he is in possession of all the documents required.
- Information and Instructions for bidders posted on website shall form part of bid document.
- The tender can only be submitted after uploading the mandatory scanned documents as per list given below.
 - Copy of valid Registration/Enlistment order of CPWD, MES, Railway, BRO, and State's PWD, PHE in appropriate class and category.
 - Insurance Surety Bond, Demand Draft/ Account Payee Banker's Cheque / FDR/ Bank Guarantee of any commercial Bank against EMD as Para 10 above.
 - Scanned copy of receipt for deposition of original EMD issued from any Formations of ITBP/office of Tender/Bid inviting authority, ITBP.
 - Certificate of Financial Turnover from CA in **Annexure-A**.
 - List of eligible similar nature of works completed during the last seven years ending last day of the month previous to the one in which tender is invited in **Annexure-B**
 - Performance report of works (mentioned in Annexure-B) **Annexure-C**.
 - Certificate of registration of GST in State Sikkim.

"If the bidder has not obtained GST registration in the state in which the work is to be taken up, then in such a case the bidder shall upload following undertaking with the bid document

"If work is awarded to me, I/ wash all obtain GST registration certificate within one month from date of receipt of award letter or before payment of 1st R.A. Bill" failing which I/we shall be responsible for any delay in payments which will be due towards me/us on account of the work executed and or for any action taken by ITBP or GST department in this regard".

- Integrity Pact duly filled and signed in presence of witnesses, scanning and uploading the same

- as per Performa given in this document (as per NIT Format).
- ix) Undertaking for site inspection (Intending bidders must upload undertaking that they have inspected and examined the site and its surrounding before submitting their bids, duly submitted (as per NIT Format)
- x) Any other document as specified in the NIT.

Note : Bidder should ensure himself that above documents are uploaded in correct format and should be readable and at correct location on the website.

5. The bid document consisting of plans, specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from website www.eprocure.gov.in & www.itbp.gov.in.
6. Those contractors not registered on the website mentioned above, are required to get registered beforehand. If needed, they can be imparted training on online bidding process as per details available on the website.
7. The intending bidder must have valid class-III digital signature to submit online bid.
8. The bidder will ensure physical submission of EMD in favour of the Commandant, 48th Bn, ITBP, Katihar, Indo -Tibetan Border Police Force or any ITBP location with intimation of this office within the period of bid submission and uploading the mandatory scanned documents such as Demand draft/Fixed Deposit Receipt/ Banker's Cheque/ Bank Guarantee of any Scheduled Bank towards EMD in the favour of the Commandant, 48th Bn, ITB police, katihar (Bihar) Mentioned in NIT.
9. Bidder should not have past track record of delaying works.
10. On opening date, the contractor can login and see the bid opening process. After opening of bids he will receive the competitor bid sheets.
11. Contractor can upload documents in the form of JPG format and PDF format.
12. Contractor must ensure to check rate of each item, if tenderer does not quote any percentage above/below on the lowest amount of the tender or any section/sub head in percentage rate tenders, the tender shall be treated as invalid and will not be considered as lowest tender.
13. The required documents meeting the criteria to qualify as "approved and eligible" contractors of CPWD, MES, Railway, State PWD, BCD, BSNL & Telecom/BSNL Deptt. etc along with other documents as mentioned under Para "List of Documents to be scanned and uploaded by the agency and hard copies received subsequently" shall be checked first, while opening the bid. The financial bid of only those agencies shall be opened who are found to be eligible agencies, as per this NIT.
14. The department reserves the right to reject any prospective application without assigning any reason and to restrict the list of qualified contractors to any number deemed suitable by it, if too many bids are received satisfying the laid down criterion.
