- 3) For submission of E-Bids, Bidders are required to get themselves registered with E-procure.gov.in website along with class-III Digital Signature Certificates Issued by CCA under IT act-2003.

- 4) Tender forms are issued free of cost to NSIC registered firms .
- 5) All Firms who are not registered with DGS & D/NSIC for the specification of subject store shall be required to deposit Earnest money as mentioned above along with tender forms.
- 6) All firms are to be deposited original copy of EMD and tender sample at the SM office of RTC KARERA (ADM BLOCK ), ITB POLICE, before bid submission closing date and time.
- 7) Following certificates are also required for submission of E-Bids.
  - i) Certificate of registration from food safety administration for supply of above Dry/Fresh ration items.
  - ii) Certificate of registration of firm from concerned district labour office .
  - iii) Technical documents viz. registration certificate.
  - iv) PAN Card , GST certificate, address proof.
  - v) Turn over/ Bank balance statement, bank cheque.
  - vi) ITR for previous three years.
  - vii) Latest GST clearance certificate.
  - viii) RTGS/ NEFT mandate form.
  - ix) Experience certificate.
  - x) Food and drug license, food safety certificate.
  - xi) And any other relevant document as per tender documents & annexures and which the firm wishes to submit.(Documents should be valid for the period of tender)
- 8) The firm or their reps ,desirous of being present during the time of the opening of tender should come and get their gate pass timely made form OC Grain shop RTC karera to avoid any hassle in getting entry into the RTC karera.
