1. The intending Bidder must read the terms and conditions of CPWD-6 carefully. He should only submit his bid if he considers himself eligible and he is in possession of all the documents required.
2. Information and instructions for bidders posted on website shall form part of bid documents.
3. The bid document consisting scope of work, the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from website www.eprocure.gov.in & itbp.gov.in
4. The tender can only be submitted after uploading the mandatory scanned documents as per list given below:-
 - a) Proprietor or one of the partner or one of the Director of the firm/consultant must be Architects (Minimum Qualification Bachelor of Architecture at least with 5 Years Experience) or structural engineer (Minimum Qualification M. Tech at least with 5 Years Experience) with valid registration from Council of Architecture and Institute of Engineers(India) respectively.
 - b) Average Annual Financial Turnover on Architectural/ Engineering Consultancy works during the last three years, ending 31st March of the previous financial year i.e. 2021-22 should be at least 15.00 Lakh. (Documentary evidence needs to be submitted).

- c) Consultancy fee received from Architectural/ Engineering Consultancy work from a single project during last three years, ending 31st March of the previous financial year i.e. 2021-22 should be at least 10 lakh. (Documentary evidence is needs to be submitted). To bring up to the current year the turnover shall be calculated with 7% compounding each year.
- d) Agency must have successfully completed the consultancy work for a RCC buildings with Electrical, Water supply, Sanitary, HVAC, Firefighting etc. all complete work of a RCC Permanent buildings at least 5 lakh (Five lakh) within three years of any Central/ State Government Deptt./ Central Public sector/ State Public sector Undertaking/Central Autonomous body / State Autonomous body/City Development authority/ Municipal Corporation of city formed under any act by central/State Government and published in Central/State gazette/listed public/private limited company. To bring up to the current year the turnover shall be calculated with 7% compounding each year.(Documentary evidence is needs to be submitted).
- e) Copy of GST registration & Pan Card.
- f) Tender form duly signed.
- g) Earnest Money shall be scanned and uploaded to the e-Tendering website within the period of bid submission. The bidder will ensure that physical submission of Earnest Money Deposit (EMD) in the office of The Dy. Commandant (Engr), SHQ (DDN), ITB Police Seemadwar, Dehradun (UKD)-248146 before as per prescribed date and time, else bid will be rejected as unresponsive bid. The EMD should be marked with the name of firm and should be forwarded on a covering letter made on letter head of the firm clearly mentioning the registration no, address, mobile no, email and fax/land line no of the firm.
5. Those Bidders not registered on the website mentioned above, are required to get registered beforehand. If needed, they can be imparted training on online bidding process as per details available on the website.
6. The intending bidder must have valid class-III digital signature to submit the bid.
7. On opening date of Financial Bid, which will be intimated after the screening process of Technical Bids, the Bidder can login and see the bid opening process. After opening of financial bids, he will receive the competitor's bid sheets.
8. Bidder can upload documents in the form of JPG format and PDF format.
9. Bidders should not have past record of delaying works.
10. Along with other documents as mentioned under para "List of documents to be scanned and uploaded by the agency and hard copies received subsequently" shall be checked first, while opening the bid. The financial bid of only those agencies shall be opened who are found to be eligible agencies, as per this NIT.
11. The department reserves the right to reject any prospective application without assigning any reason and to restrict the list of qualified contractors to any number deemed suitable by it, if too many bids are received satisfying the laid down criterion.
