The bid document consisting of plans, specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from website www.eprocure.gov.in & www.itbp.gov.in
4. The tender can only be submitted after uploading the mandatory scanned documents as per list given below.
 - a) Proprietor or one of the partners or one of the Directors of the firm/consultant must be Architect (Qualification- Bachelor of Architecture minimum at least 02Years Experience with valid registration from **Council of Architecture**. L-1 bidder should submit documentary

proof of the Structural Engineer involved in this project i.e Qualification- M-Tech in Structures with 02 Years Experience.

b) The bidder should have annual financial turnover of **Rs.7.00 lacs** during the immediate last **three (03)** audited financial years i.e. from **FY 2021-22, FY 2022-23, FY 2023-24**, The bidder is required to submit the information in **Form A (Placed at Page No. 39)**.

c) Consultancy fees from **completed projects** received from Architectural/ Engineering Consultancy work from a single project during last 03 years, ending 31st March of the previous financial year i.e. 2023-24 should be at least 3.00 lakh. **(Documentary evidence is to be submitted)**. To bring up to the current year the turnover shall be calculated with 7% compounding each year.

d) Agency must have successfully completed the consultancy work for RCC buildings with Electrical, Water supply, Sanitary. All completed work of a RCC Permanent buildings at least 1.00 Crore (One Crore) of single project within last 07 years of any Central/ State Government Dept./ Central Public sector/ State Public sector Undertaking/ Central Autonomous body/ State Autonomous body/ City Development authority/ Municipal Corporation of city formed under any act by Central/State Government and published in Central/ State gazette/ registered public/Private limited company to bring up to the current year. **(Documentary evidence is to be submitted)**.

e) Earnest Money of **Rs 12,000.00** in form of Banker's Cheque or Demand Draft or Fixed Deposit or Bank Guarantee receipt of any scheduled bank drawn in favour of DIG, SHQ (BGLR), ITBP, Bengaluru, Karnataka and deposit original EMD either in the office of **Second-in-Command (Engr) SHQ (BGLR) or any formation of ITBP within period of Bid submission time**. Receipt of EMD shall be obtained from the concerned Engineering Branch of ITBP in the prescribed format and shall be scanned and uploaded to the e-tendering website within period of bid submission. **(Placed at Page No. 40)**

f) The bidder must ensure, mandatory scanned documents and EMD in the form of Banker's Cheque or Demand Draft or Fixed Deposit or Bank Guarantee of any scheduled bank in favour of DIG, SHQ (BGLR), ITBP, Bengaluru, Karnataka is uploaded on the CPP Portal.

g) The intending Bidder must read the terms and conditions of CPWD-7/8 carefully. He/ They should only submit his bid if he considers himself eligible and he is in possession of all the documents required.

h) Information and instructions for bidders posted on website shall form part of bid documents.

i) The bid document consisting of scope of work, the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from website www.eprocure.gov.in free of cost.

j) Those Bidders not registered on the website mentioned above, are required to get registered before participation. If needed, they can be imparted training on online bidding process as per details available on the website.

k) The intending bidder must have valid class-III digital signature to submit the bid.

l) On opening date of Financial Bid, which will be intimated after the screening process of Technical Bids, the Bidder can login and see the bid opening process. After opening of financial bids, he/ they will receive the competitor's bid sheets.

m) Bidder can upload documents in the form of JPG or PDF format.

n) The department reserves the right to reject any prospective application without assigning any reason and to restrict the list of qualified contractors to any number deemed suitable by it, if too many bids are received satisfying the laid down criterion.
