Notice Inviting e-Tender

The Assistant Commandant (Engr), 5 Bn, ITB Police Force, Choglamsar, Leh - Ladakh on behalf of the President of India invites online Item rate tender from approved and eligible firms/contractors of MES, Railway, State PWD & BSNL registered in appropriate category or from the firms having experience for execution of following work :-

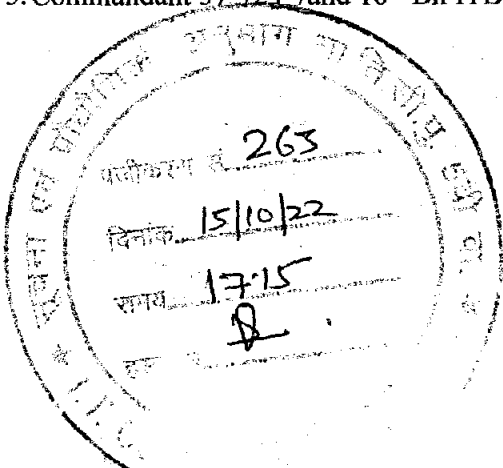
3. The enlistment of the contractors should be valid on the last date of submission of tenders. In case, the last date of submission of tender is extended, the enlistment of contractor should be valid on the original date of submission of tenders.
4. The intending bidder must read the terms and conditions of **Tender form** carefully. He should only submit his bid if he considers himself eligible and he is in possession of all the documents required.
5. Information and Instructions for bidders posted on website shall form part of bid document.
6. The bid document consisting of plans, specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from website www.eprocure.gov.in & www.itbp.gov.in.
7. The tender can only be submitted after uploading the mandatory scanned documents as per list given below.
 - I. Copy of valid enlistment in appropriate class or authorized service provider by OEM or work experience not older than 05 years (completion date of the work). The work valve shall be as per para 02 of Tender form.
 - II. Copy of GST/PAN registration.
 - III. Tender form duly signed by Contractor.
 - IV. Work experience certificate.
 - V. Scanned copy of EMD or "**Bid Security Declaration**" along with registration certificate under Micro and small enterprises whatever case may be.

- VI. List of work completed as per tender document.
- VII. Income tax return filing certificate of last three year or Income tax exemption certificate as the case may be.
8. The bidder will ensure physical submission of EMD in favour of Commandant, 5thBn, ITBP, Choglamsar, Leh - Ladakh (UT) in the form of Demand draft, Banker's Cheque/ Deposit at call receipt/ Fixed Deposit Receipt. **There is no need for submission of EMD in case bid security declaration is submitted as mentioned in Bid documents however Bid Security Declaration duly signed in specified format to be uploaded along with registration certificate with concerned authorities.**
 9. The intending tenderer has to fill all the details such as Banker's name, Demand Draft/Fixed Deposit Receipt /Pay Order/ Banker's Cheque/Bank Guarantee number, amount and date. The amount of EMD can be paid by multiple Demand Draft / Pay Order / Banker's Cheque / Deposit at call receipt / Fixed Deposit Receipts -A part of earnest money is acceptable in the form of bank guarantee also. In such case, 50% of earnest money or Rs. 20 lacs, whichever is less, will have to be deposited in shape prescribed above, and balance in shape of Bank Guarantee of any scheduled bank.
 10. Those contractors not registered on the website mentioned above, are required to get registered beforehand. If needed, they can be imparted training on online bidding process as per details available on the website.
 11. The intending bidder must have valid class-III digital signature to submit online bid.
 12. Bidder should not have past track record of delaying works.
 13. On opening date, the contractor can login and see the bid opening process. After opening of bids, he will receive the competitor bid sheets.
 14. Contractor can upload documents in the form of JPG format and PDF format.
 15. Contractor must ensure to quote rate of each item, if any cell is left blank and no rate is quoted by the tenderer, rate of such item shall be treated as "0" (ZERO). However, if tenderer quotes Nil rates against each item in item rate tender or does not quote any percentage above/below on the lowest amount of the tender or any section/sub head in percentage rate tenders, the tender shall be treated as invalid and will not be considered as lowest tender.
 16. The required documents meeting the criteria to qualify as "approved and eligible" contractors of CPWD, MES, Railway, State PWD & Telecom/BSNL Deptt., or Original Manufacturer or its registered firm with original manufacture of Generator Sets etc along with other documents as mentioned under Para "List of Documents to be scanned and uploaded by the agency and hard copies received subsequently" shall be checked first, while opening the bid. The financial bid of only those agencies shall be opened who are found to be eligible agencies, as per this NIT.
 17. The department reserves the right to reject any prospective application without assigning any reason and to restrict the list of qualified contractors to any number deemed suitable by it, if too many bids are received satisfying the laid down criterion.
