Notice Inviting e-Tender

Asst. Commandant Engineer 27th BN, ITBP, on behalf of the President of India invites online Item rate tender from approved and eligible firms/contractors of CPWD, state PWD, MES, Railways, BRO and BSNL registered under B&R /relevant civil work category in appropriate class/Specified agency in similar work/ Based on Work Experience in similar works for the following work: -

- The enlistment of the contractors should be valid on the last date of submission of tenders. In case, the last date of submission of tender is extended, the enlistment of contractor should be valid on the original date of submission of tenders.
- The intending bidder must read the terms and conditions of **Tender form** carefully. He should only submit his bid if he considers himself eligible and he is in possession of all the documents required.
- Information and Instructions for bidders posted on website shall form part of bid document.
- The bid document consisting of plans, specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from website **www.eprocure.gov.in&www. itbp.gov.in**.
- But the tender can only be submitted after uploading the mandatory scanned documents as per list given below.

6. To become eligible for acceptance of bid, the bidders shall have to furnish an affidavit as under:-

I/We undertake and confirm that eligible similar works(s) has/have not been got executed through another contractor on back-to-back basis. Further that, if such a violation comes to the notice of Department, then I/we shall be debarred for bidding in ITBP in future forever. Also, if such a violation comes to the notice of the Department before the date of start of work, the Engineer-in- Charge shall be free to forfeit the entire amount of EMD and Performance Guarantee.

7. Whose contractors not registered on the website mentioned above, are required to get registered beforehand. If needed, they may get training in the online bidding process as per details available on the website.

8. The intending bidder must have a valid class-III digital signature to submit the bid.

9. The bidder should not have a past track record of delaying works. Bids of having record of past unsatisfactory work/poor workmanship will be rejected.

10. On the opening date, the contractor can login and see the bid opening process. After opening of bids, he will receive the competitor bid sheets.

11. Contractors can upload documents in the form of JPG format and PDF format.

12. Contractors must ensure the quote rate of each item. The column meant for quoting rate in figures appears in pink color and the moment rate is entered, it turns sky blue.

In addition to this, while selecting any of the cells a warning appears that if any cell is left blank the same shall be treated as "0". Therefore, if any cell is left blank and no rate is quoted by the tenderer, the rate of such item shall be treated as "0" (ZERO). However, if tenderer quotes Nil rates against each item in item rate tender or does not quote any percentage above/below on the lowest amount of the tender or any section/sub head in percentage rate tenders, the tender shall be treated as invalid and will not be considered as lowest tender.

13. The required documents meeting the criteria to qualify as "approved and eligible" contractors of CPWD, MES, Railway, BRO, State PWD & Telecom Deptt etc. along with other documents as mentioned under Para "List of Documents to be scanned and uploaded by the agencies. The financial bid of only those agencies shall be opened who are found to be eligible agencies, as per this NIT.

14. The department reserves the right to reject any prospective application without assigning any reason and to restrict the list of qualified contractors to any number deemed suitable by it, if too many bids are received satisfying the laid down criterion.
