1. The enlistment of the contractors should be valid on the last date of submission of tenders. In case, the last date of submission of tender is extended, the enlistment of contractor should be valid on the original date of submission of tenders.

2. The intending bidder must read the terms and conditions of **Tender form** carefully. He should only submit his bid if he considers himself eligible and he is in possession of all the documents required.

3. Information and Instructions for bidders posted on website shall form part of bid document.

4. The bid document consisting of plans, specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from website www.eprocure.gov.in & www.itbp.gov.in.

5. List of Documents to be scanned and uploaded within the period of bid submission:

viii	Affidavit as per Form "E" (Page No-18) that Firm confirms that eligible similar works(s) has/have not been got executed through another contractor on back to back basis.
ix	Copies of Electrical Contractor License. If the bidder has not obtained Electrical Contractor License as applicable , then he shall scan and upload following undertaking along with bid documents. "If work is awarded to me, I/we shall obtain Electrical Contractor License, or I/we do not possess in my/our name a valid electrical license as required, I/we shall associate an agency having such a license required for execution of work as applicable, within one month from the date of receipt of award letter or before release of any Payment by ITBP, whichever is earlier, failing which I/we shall be responsible for any delay in payments which will be due to wards me/us own account of the work executed and/or for any action taken by ITBP or concerned competent authority in this regard".
x	A) Last three years Turn over (30% of estimated cost put to tender) which is not less than the Rs. 1.72 crore per year from chartered accountant as per Form –"A" (page no 14 of this tender form) Last 05 Years Profit /Loss statement – Bidder should not have incurred any loss (profit after Tax should be positive) in more than 02 years during available last 05 consecutive balance sheet , duly audited and certified from chartered accountant as per Form "A" (page no 14 of this tender form)

6. The tender can only be submitted after depositing original EMD in any ITBP formation with in the period of bid submission and uploading the mandatory scanned documents such as Demand Draft/Fixed Deposit Receipt / Banker's Cheque/Bank Guarantee of any Commercial towards EMD in favour of **DIG, SHQ (BBSR), ITBP, Vikram Nagar Camp, Taratua, Khordha (Odisha)** as mentioned in NIT & receipt for deposition of original EMD.

7. Those contractors not registered on the website mentioned above, are required to get registered beforehand. If needed, they can be imparted training on online bidding process as per details available on the website

8. The intending bidder must have valid class-III digital signature to submit the bid.

9. On opening date, the contractor can login and see the bid opening process. After opening of bids he can see competitor bid sheets.

10. Contractor can upload documents in the form of JPG format and PDF format.

11. Contractor must ensure to quote rate of each item. The column meant for quoting rate in figures appears in pink colour and the moment rate is entered, it turns sky blue.

12. In addition to this, while selecting any of the cells a warning appears that if any cell is left blank the same shall be treated as "0". Therefore, if any cell is left blank and no rate is quoted by the tenderer, rate of such item shall be treated as "0" (ZERO).

However, if tenderer quotes Nil rates against each item in item rate tender or does not quote any percentage above/below on the lowest amount of the tender or any section/sub head in percentage rate tenders, the tender shall be treated as invalid and will not be considered as lowest tender.

13. The required documents meeting the criteria to qualify as "approved and eligible" contractors of CPWD, MES, Railway, BSNL & State PWD along with other documents as mentioned under Para "List of Documents to be scanned and uploaded by the agency and hard copies received subsequently shall be checked first, while opening the bid. The financial bid of only those agencies shall be opened who are found eligible agencies, as per this NIT.

14. The department reserves the right to reject any prospective application without assigning any reason and to restrict the list of qualified contractors to any number deemed suitable by it, if too many bids are received satisfying the laid down criterion.
